#### 2. SCHOOL IMPROVEMENT

#### 2.1 HEADTEACHER'S REPORT

- 2.1.1 The Headteacher's report was circulated to the GB ahead of the meeting. There were no questions.
- 2.1 2 In response to a query from a governor the Headteacher highlighted that the list for secondary schools placements was not complete as the list does not include the results for private school placements.
- 2.1.3 The predictions for future energy costs from Haringey local authority are not encouraging and there will be a high increase in expenditure for all schools.

## 2.2 SELF-EVALUATION FORM

The latest version of the SEF was circulated to the GB ahead of the meeting. The Governors feedback was positive. The Headteacher reported the SEF is still being refined to be more concise and it was proposed to colour code the document to show progress and assist with regular updating. - Learning Corners to be installed in all classrooms the Coleridge Families have been fund raising to support the development of learning corners. An anonymous donation has also been offered to match the funding.
- NT and EWo took part in a walkabout with Paul to review safeguarding and will meet with DK to provide feedback on their findings. ACTION: NT & EWo

#### 2.3.2 Resources Committee

LG reported in RH's absence. Meeting took place on 07/03/2022.

- The Year End is due on 8<sup>th</sup> April 2022; forecast is £160k surplus at YE. This figure includes £120k Coleridge Families voluntary fund donations.
- Concern expressed over the huge increase in energy costs going forward.
- Budget 2022-2023 was reviewed and key assumptions include
  - £97 extra funding per child (£81k approx.)
  - £50k conversative prediction in parent donations of voluntary funds

Predicted utilities will increase by £93k

Expanding the reach of the Voluntary Fund being developed and ongoing co-ordinatation with Coleridge families
